Vale announces the US dollar value to be paid as additional interest on its mandatorily convertible notes:

(a) Series RIO and RIO P, US\$ 0.417690 and US\$ 0.495742 per note, respectively;

(b) Series VALE-2012 and VALE.P-2012, US\$ 0.602336 and US\$ 0.696668 per note, respectively.

The trustee of the mandatorily convertible notes, the Bank of New York, will pay the noteholders on May 7, 2010.
