

SHIPPING INSTRUCTIONS FOR SUPPLIERS

All **Suppliers MUST complete the steps** here before sending any shipments to the warehouses.

STEP 1 : PACKING & RESTRICTIONS

- 1. Packaging must be sea worthiness (standard packaging)
- 2. Pack separately for air and ocean freight
- 3. Airfreight Restriction to DENPASAR is: <u>SEE TABLE AT THE LAST PAGES</u>
- 4. For Hazardous Materials:
 - a. Packing must meet UN Standards
 - b. Need to attach MSDS
 - c. Provide UN Reference Number.
 - d. Hazardous label & symbol must put over the packing

STEP 3 : WOOD PACKAGING

- 1. All wood packaging material made from raw wood (ie. dunnage, crates, pallet etc) should be treated and certified in compliance with **ISPM#15 Standard**, and marking must conform to requirements described in Annex A.
- 2. All packages **with or without** wood packaging must be accompanied with a complete Packing Declaration/PD (Annex B)
- 3. All packages **with** wood packaging must be accompanied with valid fumigation certificate.

STEP 5: DOCUMENTATION

- 1. Mark all Purchase Order Number on the Way bill
- 2. PT VALE Purchase Order Number, Item Number and Description with stock code must be shown on the Invoice and Packing List – Please noted on the invoice and packing list, it's required to follow the goods original description on the purchase order to avoid any custom problem in Indonesia
- Total Gross and Nett Weight in kilos and dimensions in metric of each package must be shown on the Invoice and Packing List
- 4. Provide 3 sets of ORIGINAL Invoices and Packing Lists
- 5. Please avoid to put HS Code/Tariff Code in your Invoice/Packing List.
- 6. Affix 1 set of ORIGINAL Invoice and Packing List on the package
- 7. For A/F shipment, supplier is a must to be Registered Shipper in the ACS Program (For CANADA)
- Consignee and address to be written in Bill of Lading, Air Waybill, Invoice & Packing List MUST as follow: PT. VALE INDONESIA TBK SEQUIS TOWER LT.20 UNIT 6 & 7 JALAN JENDERAL SUDIRMAN KAV.71 JAKARTA 12190, INDONESIA

STEP 2 : MARKINGS

- 1. All packages should be marked according to international standards ISO/R 780.
- 2. Marking must be done clearly using ink or any other means resistant to normal weather condition using paper with plastic laminate and attached with tape. The use of printed plates is permitted.
- 3. Crates must be marked using metal or plywood sheets or other adequate support fixed between the member of the crate.
- 4. For item requiring no packaging, marking must be done directly on the goods.
- 5. Markings must be on **EVERY** package (including iso tanks), visible and readable.
- 6. Markings must have the **following details :**

PT VALE INDONESIA, Tbk P. O. NUMBER : WEIGHT : KG DIMENSION : L x W x H in cm No. of Cartons : XX of YY UN Number, if applicable (DG cargo)

STEP 4: ASSISTANCE

- 1. Air Freight shipment must be delivered by noon. Delivery after noon shall be uplifted only next following day
- 2. If in doubt, please contact Halcon Primo Logistics Helpdesk <u>hplinco@halconprimo.com</u> or person listed in the next page.
- Please contact PT Vale Indonesia,tbk's expeditors by email at <u>PTI.-.Shipping.and.Traffic.PTVI.-</u> <u>.SOR@vale.com</u> for pick up arrangement
- 4. By providing below information:
 - 1. total package
 - 2. weight and dimension per package

STEP 6 : BILLING INVOICE


- 1. Your invoice must tally with your packing list
- 2. Your invoice must show PO number, PO item number and description
- **3.** PTVI will not obligate to settle the payment as per term of payment when vendor fail to fulfill the instruction as mentioned above



<u>ANNEX A. MARKING</u> (BASED ON REGULATION NO. 12/PERMENTAN/OT.140/2/2009)



THE MARK MUST BE:


- a. Legible
- b. Durable and not transferable
- c. Placed in a location that is visible when the wood packaging is in use, preferably on at least two opposite sides of the wood packaging unit.
- d. The use of red or orange should be avoided because these colours are used in the labelling of dangerous goods or fragile cargo.
- e. All wood packaging material used in the repair, recycle, or remanufacture of wood packaging must be re-treated and re-marked in accordance with the ISPM 15 requirements.

MARK WILL NOT BE ACCEPTABLE IF:

- a. Drawn by hand.
- b. Divided across pallet/packaging.
- c. Stamp is partially visible.
- d. Use of paper/sticker.
- e. Logo presents, but treatment/certification number not.
- f. Treatment presents, but no IPPC/ISPM mark.
- g. Sticker/stamp is put outside the container, not on pallet/ packaging.
- h. Mark applied on manufactured wood part.
