## Bio Sketch Cory McPhee

Cory McPhee adalah Vice-President, Corporate Affairs, Communications and Sustainability dari bidang usaha Metal Base Vale. Lahir dan mengenyam pendidikan di Sudbury, Ontario, Kanada, Bapak McPhee bergabung pada Inco Limited terdahulu pada Public Affairs Department pada tahun 1989 dan terus bekerja untuk Perusahaan dengan memegang posisi-posisi dengan tanggung jawab yang terus meningkat sejak Vale mengambilalih Inco pada bulan Oktober 2006.
