Sebelum bergabung dengan Vale Inco pada tahun 2001, Bapak Mark James Travers sempat menjabat sebagai *Senior Associate* di sebuah perusahaan besar di Toronto, Kanada yang bergerak di bidang *Corporate & Securities Law*. Beliau bergabung dengan Vale Inco di Toronto, Kanada pada bulan Juni 2001 sebagai *Assistant General Counsel*. Pada bulan Januari 2005 beliau menjabat sebagai *Associate General Counsel* dan pada bulan September 2007 diangkat sebagai *Deputy General Counsel* untuk Asia/Pasifik sebelum akhirnya diangkat untuk menjabat sebagai *General Counsel* Vale Inco pada bulan Juni 2008. Beliau memimpin tim global pada organisasi Vale Inco yang terdiri dari sejumlah pengacara yang berkedudukan di Kanada, Indonesia, Cina, Kaledonia Baru dan Amerika Serikat.

Pada bulan April 2009, di samping mengemban tanggung jawab sebagai *General Counsel*, beliau juga merangkap sebagai *Head of Corporate Affairs* untuk Vale Inco. Pada tahun 2012, beliau menjabat sebagai Executive Vice President untuk Legal sebelum diangkat sebagai Executive Vice President untuk Legal and Sustainability di tahun 2015, keduanya di Vale Base Metals.

Pada bulan Maret 2019, beliau menjabat sebagai Interim Chief Executive Officer di Vale Base Metals sebelum akhirnya diangkat sebagai Chief Executive Officer di Vale Base Metals pada bulan Mei 2020.

Setelah memperoleh gelar Bachelor of Laws dari York University's Osgoode Hall Law school, Kanada di tahun 1993, Bapak Mark James Travers juga memperoleh gelar Bachelor of Arts (Honors) dan Master of Business Administration dari University of Western Ontario di Kanada.

Prior to joining Vale Inco in 2001, Mr. Mark James Travers was a Senior Associate practicing corporate and securities law at a large firm in Toronto, Canada. He joined Vale Inco in June 2001 as Assistant General Counsel and based in Toronto. In January 2005 he was made Associate General Counsel and then he was appointed as the Deputy General Counsel, Asia/Pacific in September 2007, a position he held until he was appointed as Vale Inco's General Counsel in June 2008. He leads a global legal team within Vale Inco consisting of lawyers located in Canada, Indonesia, China, New Caledonia and the USA.

In April 2009, in addition to his responsibilities as General Counsel, Mark assumed the duties as the head of Corporate Affairs for Vale Inco. In 2012, he became the Executive Vice President of Legal, and then became Executive Vice President of Legal and Sustainability in 2015, both at Vale Base Metals.

In March 2019, Mr. Travers was acting as the Interim Chief Executive Officer of Vale Base Metals before appointed as Chief Executive Officer of Vale Base Metals in May 2020.
