Sejak tahun 2016 sampai dengan tahun 2018, beliau merupakan Executive Vice President Banco Santander (Brasil) S.A. Beliau juga merupakan anggota Direksi Santander Security Services Ltda ("S3"). Sejak tahun 2003 sampai dengan tahun 2016, beliau merupakan Corporate Legal Director dari grup Votorantim. Beliau juga merupakan anggota dewan Aracruz Celulose S.A. (berubah menjadi Fibria S.A.) sejak tahun 2009 sampai dengan tahun 2016.



Beliau berdomisili di Amerika Serikat sejak tahun 1985 sampai dengan tahun 1996 dan merupakan Associate dan Partner di firma-firma hukum besar di Washington, D.C. dan New York, di bidang perdagangan internasional, penggabungan dan pengambilalihan, pembiayaan proyek dan pembiayaan lintas negara.

Beliau memperoleh gelar sarjana (LLB) dari Universitas São Paulo law School pada tahun 1984, gelar LLM dari Harvard Law School pada tahun 1986 dan setara gelar Juris Doctor dari George National Law Center, Washington University pada tahun 1989.

Alexandre Silva D'Ambrosio has been Vale S.A.'s General Counsel since March 2018. His responsibilities include the company's Legal, Tax, Corporate and Compliance Office sectors worldwide. He is also an Officer of Vale International S.A. and a member of the Board of Directors of Vale New Caledonia. He is a former alternate member of the Curator Council Fundação Renova.

From 2016 to 2018, he was the Executive Vice President Banco Santander (Brasil) S.A. He was also a member of the board of directors of Santander Security Services Ltda ("S3"). From 2003 to 2016, he was the Corporate Legal Director of Votorantim group. He was a board member of Aracruz Celulose S.A. (later Fibria S.A.) from 2009 to 2016.

In the United States, where he remained from 1985 to 1996, he worked as an Associate and Partner in large law firms, in Washington, D.C. and New York, in the areas of international trade, mergers and acquisitions, project finance and cross-border finance.

He obtained an LLB from the University of São Paulo Law School in 1984, an LLM from Harvard Law School in 1986, and the equivalent of a Juris Doctor degree from George Washington University's National Law Center in 1989.
